## \$3M Settlement Secured in Massachusetts Wrongful Death Case

In an instant, what seemed like a normal July morning became a family's worst nightmare. A 61-year-old man walking through a marked crosswalk in Springfield, Massachusetts, was suddenly struck by a commercial van, suffering catastrophic injuries that ultimately claimed his life. #### The Event

On July 28, 2023, at around 8:00 a.m., the victim was walking through a crosswalk on Mill Street in Springfield. At the same time, a commercial van owned by a local service company was turning left from Belmont Avenue onto Mill Street.

The driver had a clear, unobstructed view of the crosswalk. Despite this, the van struck the victim directly, throwing him several feet into the air and onto the pavement.

Emergency responders rushed to the scene. Body camera footage shows multiple EMS personnel working urgently to stabilize him as he cried out in pain. He was transported as a priority trauma patient to Baystate Medical Center, where he was admitted to the surgical intensive care unit. Despite surgery, ventilation, and weeks of round-the-clock care, his injuries were too severe. On August 9, 2023 — just twelve days after the crash — he tragically passed away, surrounded by his family.

#### **Our Legal Analysis**

From the very beginning, our <u>pedestrian accident lawyers</u> knew this case demanded relentless investigation and preparation. While liability seemed clear, the insurer for the commercial van initially disputed fault, forcing us to build an airtight case to hold them accountable and secure justice for the victim and his family.

Here's how we approached it:

- Proving visibility and right-of-way The crosswalk was fully marked, unobstructed, and clearly visible. Police body cam footage, eyewitness accounts, and accident reconstruction confirmed that the victim was in the crosswalk for several seconds before impact.
- **Exposing driver conduct** Body camera footage captured the driver admitting he was "really rushing" because he was late for work. We also documented that he was operating a company van with an expired driver's license at the time of the crash.

- Compiling decisive evidence Our investigation obtained 911 recordings, police body cam videos, witness statements, and a full crash reconstruction report. Multiple independent witnesses confirmed the victim was well into the crosswalk and visible when the van made its turn.
- Holding the company accountable As the driver was operating within the scope of his
  employment, we pursued the employer's commercial insurance coverage. By presenting
  a clear case of negligence, we secured the full \$3 million policy limits after an all-day
  mediation.

#### **Rectifying the Damage**

The \$3 million recovery provided critical financial support to the victim's family and held the company fully accountable for its role in this tragedy.

This loss was devastating on every level. The victim had recently moved to Massachusetts to be closer to his children and grandchildren. At the time of his death, one of his children was expecting a baby he would never meet. His absence left a lasting void — emotional, financial, and personal.

Our legal team guided the family through every step, coordinating the investigation, securing insurance payouts, and ensuring that no outstanding medical bills or liens would burden them in the aftermath.
